

# JOB DESCRIPTION Portfolio Valuation and Audit Officer

Based in Luxembourg, the Portfolio Valuation and Audit Officer reports to the Portfolio Valuation and Audit Manager and has the following responsibilities:

#### Financials for the funds:

- Review the quarterly NAV packs of the funds and financial reportings of the SPVs;
- Prepare the (statutory or consolidated) financial statements of the funds and the SPVs under Lux and local GAAP;
- Prepare the quarterly investor reports;
- Manage the annual audit of the funds and the SPVs (as required) with the support of the Portfolio Valuation and Audit Manager;

## Cash management of the funds:

- Monitoring and control of bank accounts, check cash balances post capital calls, cash positions, centralize all invoices, monitoring of expenses;
- Review and initiate all payments ahead of submission to Fund Admin/Transfer Agent;
- Assist with the opening of bank accounts for new funds and/or SPVs as per the local requirements.

## **Portfolio management:**

- Provide operational support to the Investment Team, the Fund Admin and AIFM (as required) during transactions (e.g. investment, distribution processes).
- Prepare the capital calls and distributions notices to investors in coordination with the Fund Admin.
- Update of the investment portfolio performance.

### Tax and regulatory:

- Work with tax advisors to stay up-to-date on regulatory topics and ensure structuring complies with the Law;
- Coordinate with local tax advisors to ensure preparation of tax returns and review their work;
- Coordinate with Luxembourg fund administrators and local providers to ensure proper regulatory reporting;
- Prepare and coordinate with local providers to ensure proper preparation and filing of FATCA & CRS returns for the funds.
