- Steer post-approval / pre-disbursement activities. Including preparation of pre-disbursement documents, conducting KYC/AML analysis and coordinate with BCPs Fund Administration.
- Steer/contribute to the activities of monitoring and investees investments until repayments/exits.
- Participate in the marketing, structuring, coordination, negotiation and closing of the exit of current portfolio companies.
- Steer valuation and audit process of investments for specific transactions and potentially on financial modeling for fundraising purposes.
- Build and maintain strong and productive relationships with clients, co-investors and partners.
- Participate and contribute to the respective internal meetings and engage in BCP related activities.
- Share knowledge and actively expand your knowledge through "on-the-job" learning activities.
